PETITION FOR REDRESS

We are the Elders of Awutu Ayorkor Gate 1 family of Awutu Breku in the Central Region of the Republic of Ghana.

Abusuapanyin Nana Kofi Ashiao (deceased) was the former Head of Awutu Yorkor Gate I family of the Central Region of the Republic of Ghana he has passed on about 9 months ago and is yet to be buried. As he advanced in age and as a king maker, he nominated and installed one Kwaku Annan Acheampong as chief of Awutu Yorkor Gate I, now known by a stool name as Kwaku Osimpo Acheampong III.

Since Kwaku Osimpo Acheampong III was installed chief of Awutu Yorkor Gate I, he has been selling our family land without rendering any account to the Elders of the family. He has recently sold about 35 acres of the family land to a Church without the knowledge of the Elders of the family.

As it is the utmost desire of the Elders of the Awutu Yorkor Gate I family to bring development to Awutu Breku, we recently contracted a contractor called **Chamber Estates**, located at Nyanyano to grade a portion of the family land at Awutu Breku for the construction of School, Hospital, Market, Police Station, Lorry Park etc. for the town.

It is not the agenda or plan of the current Chief to bring development in the town. So he is vehemently opposing our development agenda. He has decided to thwart every effort and move of ours to initiate and or bring any development project to the town.

When School, Hospital, Police Station, Market and Lorry Park are built in the town we believe it will bring development as well as create employment for the teeming youth in the town.

Awutu Yorkor Gate I, has for many years, not seen any development.

The stance of Chief Kwaku Osimpo Acheampong III is likely to bring confusion in the family and the town as a whole which we are trying very hard to avoid. **We are for peace.**

He has claimed ownership of the family land at Awutu Breku and therefore selling it as and when he wishes. He did not want anyone to poke his or her nose in the affairs of the land. He does not respect any elder or member of the Awutu Yorkor Gate 1 family.

We are hereby petitioning your high office to use your good offices to intervene and address this matter.
