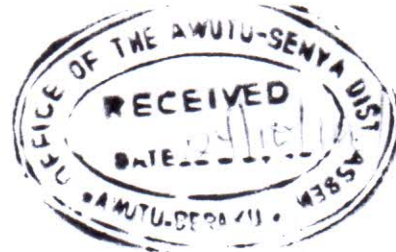

PETITION ON THREAT AND PHYSICAL ATTACK ON ME AND MY FAMILY

I wish to formally bring to your door steps as the Chairman of DISEC and DCE of Awutu east District the countless physical and verbal threats being meted to me and my family in Awutu Bawjiase led by one Kwao Abiesi, which case I have lodged complain at the Bawjiase Police Station severally but the Commander and his subordinates have not given the needed attention to my predicaments, a clear indication of biasness and partiality of which case you are aware of as I have been to your house on two occasions to complain to you which you promised to enquire from the District Police Commander but have heard or seen nothing positive from you since.

Please Sir, for your information, the situation is getting out of hand as Kwao Abiesi and his gang has resulted to physical attacks on my sister and her daughter on 10th October, 2019 in the night at about 8.00pm, the daughter was chased by three young men on her way home and she had to hit one with a big bowl she was holding in order to free herself from his grip and with shouts they stopped pursuing her. The mother on her way to town in the night was also attacked by three young men. Only God knows what they want to do to them.

On my part Kwao Abiesi, Kweshie Boduwa, Dada Broni and one black young man, a son of Kwao Abiesi have threatened me to leave the land I have bought for about 17 years for them, which case is at the Bawjiase Police and nothing has been done to stop Abiesi and his gang from such unlawful act. They have rather condoned with them to trespass on the land, which case I have also forwarded to the CID Headquarters. These people have severally threatened to eliminate me from the surface of the earth (by using the Akan language yebete wo te) and true to their threats I walk in the night and see strange people following me as I arrive from work late in the night. And where I live I see strange people in

and out of the house since it is an open building from time to time., normally during weekends when I am at home.

They have trespassed my and destroyed properties on the land. What they want to take from me now is my LIFE. So as they would possess the land.

Sir, why is the Awutu Police putting up such attitude against me? And have refused to arrest those suspects and bring them to book when a case of threat and attacks was reported. Am I not a Ghanaian citizen? Also am I not entitled for protection and fair treatment under the law?

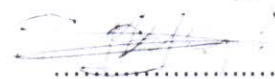
Please if you care to know I am working for the country Ghana as a professional teacher attaining the position of an Assistant Director I. I play the headship role at the post of Principal Superintendent, manning a whole basic school, having about 20 teachers under my control. Hence, the implication here is I have also contributed my quota to mother Ghana and I don't deserve this unfair treatment from the district security. Now the lives of I and my family are in danger. Do you want us to be killed before the right thing is done?

This Kwao Abiesi and his gang are terrors, seizing peoples' lands and with impunity and the Awutu Bawjiase Police is aware of them and their activities.

Please Sir, I am per this petition given you and your outfit one week to let me hear from you with all humility before the next step would be taken to ensure my safety.

I rest my petition here and thank you for your audience and cooperation.
